













TN PULSE Compliance Symbol Guide







Special Education Compliance Symbols

-  The student is fully compliant with all IEP/ISP and eligibility requirements.
-  The student has been determined eligible for special education and will soon require their 3-year re-evaluation.
-  The student is eligible and has an IEP/ISP and will soon require that a new IEP/ISP be written.
-  The student has recently transferred into this school system and will soon require that a new IEP/ISP be written.
-  The student has been determined eligible for special education and is past due for their 3-year re-evaluation.
-  The student has been referred (and may have parent consent to evaluate). The student is now past due to receive their initial eligibility determination.
-  The student is eligible and has an IEP/ISP but is now past due to have a new one written.

504 Compliance Symbols

-  The student is fully compliant with all Section 504 Plan and eligibility requirements.
-  The student has been determined eligible for Section 504 and will soon require their 3-year re-evaluation.
-  The student is eligible and has a Section 504 Plan and will soon require that a new Section 504 plan be written.
-  The student has been determined eligible for Section 504 but is past due for their 3-year re-evaluation.
-  The student is eligible and has a Section 504 plan but is now past due to have a new 504 Plan written.

ILP/ILP-D Compliance Symbols

-  The student is fully compliant with all ILP-D timelines.
-  The student is compliant for all ESL eligibility and plan timelines.
-  The student is eligible for ILP-D and has an ILP-D and will soon require a new plan.
-  The student is eligible for ESL services and will soon require an ILP.
-  The student is eligible for ILP-D and is overdue to have a new plan written.
-  The student is eligible for ESL and is overdue to have a new plan written.

Early Childhood (ECO) Compliance Symbols



The student is ECO Compliant. The student has ECO entrance and ECO exit data entered in TN PULSE. *Regardless of age or grade, if a student has both entrance and exit data, the green checkmark should display.*



Early Childhood (ECO) Exit Coming Due. The student has ECO entrance data in TN PULSE, and the student has at least 6-months of service. *6 months of service is calculated from the date entered on the Date of ECO Entrance Rating field for the respective student to the current date.*

The student age is at least 5 years, 6 months AND in preschool, or ECO Exit Data has not been entered yet in TN PULSE.



Early Childhood (ECO) Past Due. The student has ECO entrance data in TN PULSE, ECO exit data has not been entered yet in TN PULSE, the student has at least 6-months of service. *6 months of service is calculated from the date entered on the Date of ECO Entrance Rating field for the respective student to the current date.*

The student turns 6 years of age while in preschool OR moves to kindergarten (if student moves to kindergarten with less than 6 months of service, the calculation for 6-month of service stops. The red stop sign will never display for this student).



Early Childhood (ECO) Entrance Missing Warning. The student age is less than 5 years 6 months, the student has an initial eligibility in TN PULSE, the student does not yet have active IEP in TN PULSE, the student is in preschool, or the ECO entrance data has not been entered yet in TN PULSE.



Early Childhood (ECO) Entrance Missing Noncompliant. The student's age is less than 5 years 6 months, the student has initial eligibility in TN PULSE, the student has current active IEP in TN PULSE, the student is in preschool, and ECO entrance data has not been entered yet in TN PULSE.

General Education Compliance Symbols



The student had a non-eligibility document finalized and no longer qualifies for special education services.



This compliance symbol will display for any student for which a discontinuation of parent consent occurred. The student has returned to the general education population.



Student has been referred (and may have a parent consent to evaluate). The student will soon need their initial eligibility determination completed.



The student is not eligible for any type of special education.



The student had a non-eligibility document finalized and no longer qualifies for special education services.

TEIS Ages 0-3 Compliance Symbols



When the child's record is imported into TN PULSE from TEIDS, a yellow yield symbol with the number 3 is displayed indicating eligibility should be determined and, if eligible, an IEP developed by the child's third birthday.



When the child's record is imported into TN PULSE from TEIDS is 3 years and 1 day old without a finalized IEP, a red stop sign with the number 3 is displayed. The red stop sign will remain until an action is taken to determine the child's eligibility and, if eligible, develop the IEP.
