Division activities include the establishment of water quality criteria; issuance of permits and certifications; evaluation of monitoring data; conducting inspections; management of financial assistance for infrastructure and oversight activities related to stream channel modification, wetland alterations, dredging, groundwater protection, wellhead protection, safe dams, septic systems, pretreatment, biosolids application, and stormwater.

### General Responsibilities:

- Support the implementation of multiple programs within the Division of Water Resources including inspecting the construction of on-site sewage disposal systems, augering and probing areas in support of soil suitability determinations and collecting water samples.
- Access permit document database and interpret permit documentation.
- Operate common surveying equipment including leveling and taping devices.
- Communicate construction deficiencies to system installers.
- Prepare as-built construction documents using the appropriate digital documentation framework.
- Instruct entry-level Environmental Technicians.
