Are you looking for an opportunity to work with Tennessee State Parks? Our Tennessee State Parks are among the most beautiful parks in the United States and provide outstanding opportunities to work in beautiful work environments. This position is in historic Beersheba Springs, TN at the newly established Savage Gulf State Park. The Park is a 18,500-acre natural area that offers 55 miles of hiking trails that lead to backcountry campgrounds, remarkable vistas, waterfalls, and historic sites.

This position has a variety of responsibilities including the requirement of a flexible work schedule, including the ability to work evenings, weekends, and holidays. The preferred candidate will be comfortable working with diverse guests of the park, interacting with a variety of wildlife, and enjoy interpretive programming. The position will also have supervisory oversight of other park staff or volunteers working in the park. To be considered for this position you must have a bachelor's degree; preferred degree in Resource Management or a Natural Resource based field of study. It is also a requirement that the candidate be a state commissioned officer recognized by the Tennessee Law Enforcement Training Academy or is willing to become commissioned. ### **Highlighted Responsibilities:**

- Manage assigned operations responsibilities and assist with management of all operations and visitor services.
- Assist with community outreach programs and partner with local businesses and area officials to promote the park to impact economic development.
- Support Park and natural area goals of resource protection and management in invasive removal, restoration of natural and cultural areas, and visitor education of resource significance.
- Supervise full time and seasonal ranger staff.
- Act as the field training officer for new rangers and seasonal staff and safety and security officer for the park.
- Execute disciplinary action including the enforcement of park rules and regulations and all other state laws when necessary. Investigate complaints and reported offences.
