

TDEC Rulemaking Hearing to be held July 11, 2023 – Asbestos Accreditation Requirements

The Tennessee Department of Environment and Conservation (TDEC) Division of Solid Waste Management (DSWM) will hold a hearing on the proposed repeal Chapter 0400-13-02 Asbestos Accreditation Requirements and move its existing requirements with updates to Chapter 0400-13-02. At the hearing, DSWM will present and receive comments on this proposal.

The hearing will be held in the Multimedia Room on the third floor of the Tennessee Tower, 312 Rosa L Parks Ave, Nashville TN 37243, on July 11, 2023, at 1:00 pm CST.
