| NRS21.230 | Applicant: Riverton Development, LLC Activity: Riverton Development proposes to permanently impact the Tennessee River near Lupton Drive in Chattanooga (Hamilton County) with 75 feet of rip rap bank stabilization, 3,380 feet of buffer alterations, and 0.57 acres of wetland fill for development of a mixed-use residential community. Buffer impacts will be offset onsite and wetland impacts offset through purchase of 1.2 credits from the Sequatchie Valley Wetland Mitigation Bank.. |

NRS23.144 **Applicant:** Tennessee Department of Transportation (TDOT)
Activity: The Tennessee Department of Transportation proposes temporary impacts to 250 feet of unnamed tributaries to Trussle Creek for encapsulation during a rockfall prevention project on Interstate 24 eastbound at log mile 5.6 near Monteagle (Grundy County).

NRS23.310 **Applicant:** Tennessee Valley Authority (TVA)
Activity: The Tennessee Vally Authority proposes temporary impacts to 0.38 acres of wetland and 23 streams and permanent impacts to 0.41 acres of wetlands in Bristol (Sullivan County) for the construction of a new transmission line. Temporary impacts will be restored to pre-existing conditions. Wetland impacts will be mitigated through purchase of 0.51 credits from the Lick Creek Mitigation Bank 2.

NRS23.315 **Applicant:** ARCO/Murray National Nashville, LLC
Activity: ARCO/Murray National Nashville, LLC proposes to impact 453 feet of stream with three-sided box culverts and fill 0.66 acres of wetland for construction of a warehouse facility. Mitigation for impacts to aquatic resources will be through purchase of 232 functional feet stream credits from Brady Branch Mitigation Bank and 1.33 wetland credits from Gleason Creek Mitigation Bank.

NRS24.052 **Applicant:** Gatlinburg Airport Authority, Inc.
Activity: The Gatlinburg Airport Authority proposes 0.87 acres of wetland impacts for runway relocation (Sevier County). Tennessee Public Chapter No. 170, January 1, 2024, exempts from compensatory mitigation an amount of wetland equal in size to the area for which mitigation would not be required if the permit qualified for a general permit. Therefore, 0.77-acres of wetland impact is proposed for compensatory mitigation through purchase of 1.54 credits from the Lick Creek Wetland Mitigation Bank #2 in Sevier County.

NRS24.062 **Applicant:** Tennessee Department of Transportation (TDOT)
Activity: The Tennessee Department of Transportation is proposing 143 feet of rip rap armoring of the bed and bank of an unnamed tributary to Willow Branch in Dickson (Dickson County) for rerouting of a stormwater outfall near State Route 46.

Applicant: Tennessee Department of Transportation (TDOT)
Activity: Unavoidable permanent impacts to up to 480 linear feet of stream associated with bank stabilization for emergency roadway repairs on State Route 141 near Lancaster, Tennessee. Based on the information provided, the Commissioner has determined that pursuant to rule 0400-04-07- .04, an emergency exists. This emergency permit shall be advertised by public notice no later than 20 days after issuance.
