Call to Order

Juanita Turnipseed, Panel Chair, called the meeting to order at 2:00 p.m. in the Mockingbird Room located at 665 Mainstream Dr., Nashville, TN 37243.

Hearing

Ms. Megan Gottschall, Assistant General Counsel, opened the hearing stating the necessity for the emergency meeting of the panel of the board for the summary suspension of Ms. Dawn Bechard, LPN license # 21343.

Ms. Gottschall presented the case for summarily suspending the license of Ms. Bechard. Following presentation and testimony and discussion by the panel, Ms. Akins moved to accept the findings of fact 1 through 23 on the final proposed order. Ms. Cecil seconded, motion carried.

Ms. Cecil moved to accept the conclusions of law based on violations T.C.A 63-7-115 (a) (1) (C) (E) (F), T.C.A 63-1-120 (a) (1) (C) and rule 1000-02-.13 (1) (j) as written in the state's proposed order. Ms. Akins seconded; motion carried.

Ms. Akins moved that the preliminary findings of the severity of the misconduct by Ms. Bechard imperatively requires emergency action and moved to summarily suspend the license of Ms. Bechard, LPN 21343 and adopt the proposed order of summary suspension as presented. Ms. Cecil seconded, motion carried.
