ABM Educational Services Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff on December 31, 2022. The total number of affected workers is 80. The layoff is due to contract cancellation. This company is located at 830 Fesslers Parkway, Nashville, TN 37210. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on December 16, 2022.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce

Essentials, has been notified to coordinate services with the employer and affected employees. The Southeast Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
