Ameri-Kleen, Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure on February 17, 2024. The total number of affected workers is 80. This company is headquartered at 433 Nissan Blvd, Suite 302, Smyrna, TN 37167. The employees are being dislocated from 199 Sam Ridley Pkwy E, Smyrna, TN 37167. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on December 18, 2023.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials, has

been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
