Apex Canvas CO LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff on September 28, 2023. The total number of affected workers is 8. This company is located at 500 RPM Drive, Loudon, TN 37774. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on September 19, 2023.

The employees at the facility are not represented by a collective bargaining agreement. The East Local Workforce Development Area rapid response team, employed by ETHRA has been notified to coordinate

services with the employer and affected employees. The East, Local Workforce Development Board, will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
