KIPP Memphis Academy Middle School has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure on June 1, 2023. The total number of affected workers is 40. This company is located at 2210 Howell Avenue, Memphis, TN 38107. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 4, 2023.

The employees at the facility are not represented by a collective bargaining agreement. The Greater Memphis Local Workforce Development Area rapid response team, employed by Workforce Midsouth, has

been notified to coordinate services with the employer and affected employees. The Greater Memphis, Local Workforce Development Board, will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
