Viviant Healthcare of Murfreesboro has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure. The facility expects layoffs to begin around December 20, 2023, with all separations complete by Jan 14, 2024. The total number of affected workers is 79. This company is located at 1530 Middle Tennessee Blvd., Murfreesboro, TN 37130. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on February 21, 2023.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials, has been notified to coordinate services with the employer and affected employees. The Northern Middle Local
