Airport Management Services and Hudson Group has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a layoff that is permanent for 16 workers and indefinite for 3 workers. The layoff is effective on October 1, 2020. The total number of affected workers is 19. This company is headquartered at 1 Meadowlands Plaza, #902, East Rutherford, NJ 07073. The affected location is 1 Terminal Drive, Nashville, TN 37214. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on September 9, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area's rapid response team, employed by Workforce Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
