Atrium Hospitality dba Embassy Suites Murfreesboro has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective beginning March 12, 2020. The total number of affected workers is 119. Although the company anticipates the layoffs will remain temporary, at this time, they cannot guarantee this. This company is located at 1200 Conference Center Blvd., Murfreesboro, TN 37129. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on May 19, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
