Central Research, Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective June 15, 2020, with all separations accomplished by July 31, 2020. The company states, "We hope this layoff will be temporary, however, this will depend on our contract with the U.S. Department of Education." The total number of affected workers is 111. This company is located at 400 N. Belvedere Gallatin, TN 37066. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on July 7, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
