City Winery Nashville, LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a layoff that was originally intended to be temporary. The company now states, "City Winery is now expected to have limited or no operations for a period of four (4) to six (6) months or more." The layoff was originally effective on March 15, 2020. The total number of affected workers is 117. This company is located at 609 Lafayette St., Nashville, TN 37203. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on June 16, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce

Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
