Marriott Hotel Services, Inc dba Nashville Airport Marriott has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure which is effective March 1, 2021. The total number of affected workers is 182. This company is located at 600 Marriott Drive, Nashville, TN 37214. The company will cease all operations at this location. This notice follows WARN # 202000209 filed by the company in June 2020, wherein the company stated, "it is reasonably foreseeable that these temporary actions may extend beyond six months." The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on December 31, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
