McKesson Pharmaceutical Solutions and Services has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure which is effective March 4, 2020, with all employees being separated by June 4, 2020. The total number of affected workers is 79. This company is located at 4971 Southridge Blvd., Memphis, TN 38141. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on March 11, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Greater Memphis Local Workforce Development Area rapid response team, employed by the Grant

Associates Tennessee Development District has been notified to coordinate services with the employer and affected employees. The Greater Memphis Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
