This company is located at 198 Union Ave., Memphis, TN 38103 The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on March 26, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Greater Memphis Local Workforce Development Area rapid response team, employed by the Workforce Investments Network has been notified to coordinate services with the employer and affected

employees.
