Perry Community Hospital has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary closure which is effective November 27, 2020. The total number of affected workers is 28. This company is located at 2718 Squirrel Hollow Drive, Linden, TN 37096. The company stated, "We hope to reopen within the next two months". The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on December 4, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Southern Middle Local Workforce Development Area rapid response team, employed by the South

Central TN Development District has been notified to coordinate services with the employer and affected employees. The Southern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
