Prestige Maintenance USA, L.P. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective March 19, 2020. The total number of affected workers is 52. This company is located at 1808 10th St., # 300, Plano, TX 75074. The company operates in 28 locations within Tennessee. Those locations are in the following counties; Davidson, Rutherford, Maury, Williamson, Wilson, Anderson, Hamilton, Putnam, Knox, Sumner, Madison, Washington, Blount, and Hamblen. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on March 25, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by the Mid-Cumberland HRA has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
